## **30-0088 IS A COMPONENT OF THE KITS IDENTIFIED IN TABLE 2**

North American Rescue (NAR) is voluntarily recalling **product 30-0088 Lots 021224-1, 81722-1**, **81722-2 and 121323-1**. We are recalling these products due to a potential manufacturing defect that may compromise the structural integrity of the device and the product's performance during use.

Affected products were shipped between **July 16, 2024, and May 30, 2025**. This product was shipped individually and in kits. Affected products and lot numbers (including kits) are listed in **Table 1** and **Table 2**.
