

Terms

By entering this giveaway (**Giveaway**), you agree to these terms. North American Rescue, LLC (NAR) is the sponsor of the Giveaway. Consent to receive marketing communications is optional, is not required to enter or win, and will not affect your chances of winning. **If you separately consent to receive marketing e-mails, you may unsubscribe at any time using the instructions in those e-mails. All eligible entries will be considered equally.**
